Amplified Noise Permit

In order to limit the number of police calls for service regarding noise complaints, the Napa Police Department will not authorize an amplified Noise Permit for a residential address later than 9pm.

Commercial properties or halls, requesting an Amplified Noise Permit, will be granted up to 11pm, depending on the location as it relates to residential neighborhoods.

All applications are screened for prior police response. Additional time restriction may be made at the discretion of the Napa Police Department based on this information. In addition, time restrictions may also be made based on the day of the week and or other circumstances, which given historical information, would most likely cause a police response.

Once your permit is approved, you will receive a call or email advising you that your permit is ready for pick up at the front counter of the Napa Police Department.

If you're submitting an application on Friday, for an event the same weekend, request to speak to the on duty patrol sergeant.

Amplified Noise Permit Request

The council enacts this legislation for the sole purpose of securing and promoting the public health, comfort, safety and welfare for its citizenry. While recognizing that the use of sound amplifying equipment may be entitled to certain protection by the constitutional rights of freedom and speech and assembly, the council finds that in order to protect the public safety and the correlative rights of the citizens of this community to privacy and freedom from public nuisance of loud and unnecessary noise, reasonable regulation of the time, place, and manner of the use of amplifying equipment is necessary. In no even shall any approval or authorization required herein be withheld by reason of the content of any material proposed to be broadcast through amplifying equipment. As of November 1st, 2014, there is an associated fee of \$41.00 for the application, which is non-refundable regardless of approval or denial of permit. Napa Police Department Records will collect the fee at the time of application and they accept cash, credit card, or personal checks.

Once the following questions have been answered and submitted, you will be notified by phone or email with a decision regarding your request with 5 business days.
