City of Napa requires an approved permit and certificate of insurance for all commercial boating at any of the municipal boat docks or boat launching areas. Commercial operators using the Main Street Boat Dock require an approved landing rights agreement with Tideline Marine Group. Alcohol cannot be served or consumed without an additional approved permit and will be subject to additional insurance and fees. A permit is required each year and available starting December 1st for the following year. The Parks & Recreation Department reserves the right to limit the number of commercial operators and hours of use at each location.
