**Post Construction Stormwater Quality Requirements**

Type of Project	Stormwater Control Plan
Roads and Linear Utility Projects (LUP's) that create 5,000 SF or more of newly constructed, contiguous impervious surface	X
Single family homes-projects that create or replace 2,500 SF or more of impervious surface	X
Small projects that create or replace between 2,500 and 5,000 SF of impervious surface	X
Regulated projects other than single family homes that create or replace 5,000 SF or more of impervious surface	X
Projects building on slopes of 5% or greater	X

1. Each project submitted should be run through the "Stormwater Best Management Practices During Construction Requirements" checklist to check for applicability.

2. Each Project submitted should be run through the "Post Construction Stormwater Quality Requirements" checklist to check for applicability.

3. Applicants should visit the State Water Resources Control Board at: [https://www.waterboards.ca.gov/water\\_issues/programs/stormwater/industrial.html](https://www.waterboards.ca.gov/water_issues/programs/stormwater/industrial.html) to find out if their project(s) qualify for a General NPDES Permit for Stormwater Discharges Associated with Industrial Activities.
4. Projects that meet stormwater requirements need to submit one (1) set of plans with attention to Public Works/Stormwater review prior to project approval.
