

Suppliers of Recycled Paper Checkout Bags Ordinance effective January 1, 2015

Suppliers on this list carry Recycled Paper Bags that meet requirements set by the City of Napa's Single-use Carryout Bag Reduction Ordinance. The paper bags your store offers for sale at checkout must meet the following requirements:

- Paper bag fibers must contain no old growth fibers
- Bags must be a minimum of 40% post-consumer recycled content paper
- Bags must be 100% recyclable, including the handles
- Bags must have all the following information printed in a highly visible manner on the outside of the bag (typically on the bottom/ underside):
 - Words "Reusable" and "Recyclable"
 - Name and location of the manufacturer
 - The percentage of post-consumer recycled content paper
